## COTON-IN-THE-ELMS PARISH COUNCIL

Minutes of a Parish Council meeting held on 27<sup>th</sup> July 2015, at the Community Centre, Coton-in-the-Elms.

#### Present

District Councillors Mrs E Hall and P Murray and County Councillor Mrs C Lauro were also in attendance.

Mr PG Davies, the Parish Clerk, was also present.

### 1. MINUTES

#### **RESOLVED**

That the minutes of the meeting held on 22<sup>nd</sup> June 2015, be approved and signed as a correct record.

### 3. VILLAGE BROOK

The Clerk reported that the District Council had acknowledged that they were responsible for that part of the brook between New Road and Church Street. An officer had inspected the brook and had advised that no maintenance or clearance work was required at this stage. They would keep the matter under regular review.

# 4. PLANTING OF TREES - VILLAGE GREEN

The Parish Council noted that all the statutory utilities had indicated that they had no apparatus in the vicinity of the six trees to be planted in memory of soldiers killed in the First World War. Final approval was awaited from the County Council but the Clerk had been informed that this was now a formality.

#### **RESOLVED**

1. That the Clerk, in liaison with the Chairman, arrange with Trelawn Services to plant six rowan trees in the positions previously agreed by the Parish Council.

- 2. That the Clerk arrange for a plaque to be provided to incorporate suitable wording in memory of those six soldiers who had made the supreme sacrifice in the First World War.
- 3. That the Chairman of the District Council be invited to the Unveiling Ceremony on 3<sup>rd</sup> November 2015, at 2.00 p.m. on site.

### 5. PLANNING APPLICATIONS

The Parish Council noted that in respect of the pre-consultation on the wind turbines, the Clerk, after receiving an approach from Councillor Mrs S Campion, had added the following wording:-

"It had been brought to the Parish Council's attention that individuals in neighbouring parishes had been consulted direct. Why is this not the case in Coton-in-the-Elms where the prevailing wind may result in noise being greater in this parish than in others. Each household in Coton-in-the-Elms should be consulted."

#### RESOLVED

That the action taken be approved and confirmed.

#### 6. ROLL OF HONOUR

Councillor M Kinson displayed the Roll of Honour which had received a new frame. The work had been carried out by Mr M Webster of 160 Sycamore Road, Burton-on-Trent.

Councillor Kinson had kindly agreed to meet the cost of the work.

That the Parish Council place on record its thanks to Councillor Kinson and that the Clerk send a letter to Mr M Webster thanking him for the excellent work done in providing a new frame for the Roll of Honour.

County Councillor Lauro indicated that she would be carrying out a site inspection with Mr N Walis from the Depot at Willington and would report the outcome to the next meeting.
