## 8. SOUTH DERBYSHIRE DISTRICT COUNCIL – LOCAL PLAN

The District Council was inviting comments on the Draft Local Plan Part 2. The last date for comments was 15<sup>th</sup> August 2016.

The Parish Council noted there were no non-strategic housing allocation sites in Coton-in-the-Elms. There was, however, a site identified off Mill Street in the housing site options part of the Plan. Details of the site were circulated at the meeting.

## **RESOLVED**

That the Clerk respond to the consultation by informed the District Council that if, in due course, there is any proposal to develop site: SO.065 [land off Mill Street], the Parish Council would object in the strongest possible terms on the following grounds:-

- Highway issues
- Lack of proper infrastructure, including adequate sewerage system

- The consequential increased risk of flooding
- Lack of amenities
- School is already full to capacity

## 14. PUBLIC SESSION

The Vice-Chairman adjourned the meeting to allow a member of the public present to address the Parish Council.

Reference was made to the following:-

- the speed and volume of vehicles passing through the parish;
- the possibility of introducing traffic management measures such as a raised junction at the entrance to the village to slow traffic as it entered the built-up area;
